South Texas Ranch Crime Index Total as of May 31, 2017: 44

The Ranch Crime index comprises rancher input of criminal traffic patterns occurring outside of main highways and roadways, and across ranch properties.

MARFA SECTOR

USBP Agents seized 106.78 lbs of marijuana and apprehended three IAs near a ranch northwest of Marfa. The subjects and the marijuana were referred to Alpine DEA.

USBP Agents apprehended 10 IAs on a ranch 15 miles southeast of Sierra Blanca.

Van Horn USBP Agents seized 320.40 lbs of marijuana and apprehended three IAs near a ranch south of Van Horn. The IAs and the marijuana were referred to El Paso DEA.




On 08 MAY, a USBP Agent conducted a traffic stop on a 2004 Nissan Armada in Brackettville. The driver sped away and crashed through a fence, and the occupants bailed out. Agents apprehended three IAs, one of whom was a juvenile.

On 15 May, USBP Agents found two duffel bags containing a total of 74.97 lbs of marijuana on a ranch southeast of Eagle Pass. An Agent searched the area and apprehended three IAs. The marijuana was turned over to DEA.

On 15 May, a USBP Agent conducted an inspection on a red 2005 Ford Explorer on US-57, when two subjects bailed out and absconded onto a ranch west of Batesville. The Agent and a Zavala Co SO Deputy detained the female driver and an IA. The driver was identified as the alien smuggler and was arrested. USBP deferred prosecution on the driver, who was released with the vehicle.

On 13 MAY, a Zavala Co SO Deputy conducted a traffic stop on a red 2001 Ford F-150 pickup on US-57 west of Batesville. The vehicle crashed through a ranch fence. The driver bailed out and absconded.







On 12 MAY, a Zavala Co SO Deputy conducted a traffic stop on a black 2011 Ford F-150 pickup on US-83 south of La Pryor, when a pursuit ensued. The vehicle drove through a ranch fence, and the driver bailed out and absconded. The vehicle was reported stolen out of Houston.

On 21 MAY, a Zavala Co SO
Deputy assisting USBP
conducted a traffic stop on
a silver 2005 Chevrolet
TrailBlazer on US-83 south
of La Pryor, when a pursuit
ensued. The vehicle
crashed into brush on a
ranch, and several subjects
absconded. The Agents
impounded the vehicle.





On 29 MAY, USBP Agents discovered an abandoned duffel bag on a ranch north of El Indio. The duffel bag contained 12.30 lbs of marijuana and was referred to DEA.

On 20 MAY, a Dimmit Co SO Deputy conducted a traffic stop on a white 2016 Ford F-150 pickup on FM 133 near Catarina, when a pursuit ensued. The vehicle drove into oncoming traffic and the Deputy lost contact with the vehicle. On 21 MAY, a USBP Agent found the Ford abandoned on a ranch west of Big Wells. The vehicle had multiple license plates and a false company logo. The Ford was reported stolen out of San Antonio.



On 25 MAY, USBP Agents observed a black 2012 Ford F-150 pickup on SH-85 near Carrizo Springs. The vehicle immediately accelerated and crashed through a fence onto a ranch. The vehicle was later located abandoned. The vehicle was reported stolen out of Austin. The following morning, two subjects were observed walking near the Nueces River Bridge in Carrizo Springs. The Agents responded and apprehended the two IAs who were involved in the bailout. One of the IAs was identified as the driver, and was arrested by the Dimmit Co SO for Possession of a Stolen Vehicle.

LAREDO SECTOR

On 09 MAY, USBP Laredo Agents responded to an abandoned 2017 Ford F-250 pickup on a ranch near Catarina. The vehicle's front and rear license plates were different, and it had been stolen from San Antonio.

On 30 MAY, USBP Hebbronville
Agents responded to a smuggling
attempt at a ranch near Bruni. The
Agents conducted a traffic stop on a
2011 Ford F-150 pickup, and the
driver bailed out. The Agents seized
612 lbs of marijuana and the subject
was apprehended. The marijuana,
vehicle, and driver were turned over
to DEA and FBI.



LAREDO SECTOR

On 22 MAY, USBP Laredo Agents found an abandoned 2001 Oldsmobile Bravada near a ranch community in the Laredo area. The subjects were observed absconding into Mexico. A search revealed 292.22 lbs of marijuana.

A subject was arrested, and the vehicle was seized.



RIO GRANDE VALLEY

A La Joya PD Officer conducted a traffic stop on a 2006 Ford Expedition, when a pursuit ensued. The vehicle crashed into a fence and the driver was arrested, along with four IAs, who were referred to USBP.







A Brooks Co SO Deputy assisted by USBP Agents responded to a ranch in northern Brooks County regarding a deceased person whose body had been discovered by the ranch foreman. The deceased male subject was clothed, and had an ID from El Salvador and a cell phone.

COASTAL BEND SECTOR

On 15 MAY, a Matagorda Co SO Deputy conducted a traffic stop on a 2004 Chevrolet Silverado pickup, when a pursuit ensued. The vehicle crashed through two fences. When it stopped, 15 subjects bailed out and absconded. The vehicle was confirmed stolen from Houston.





