South Texas Ranch Crime Index Total as of July 31, 2017: 47

The Ranch Crime index comprises rancher input of criminal traffic patterns occurring outside of main highways and roadways, and across ranch properties.

MARFA SECTOR

Marfa USBP Agents, assisted by CBP AVN, seized 338.54 lbs of abandoned marijuana in burlap bundles on a ranch northeast of Ruidosa. The marijuana was referred to DEA.



Marfa USBP Agents seized 180.35 lbs of abandoned marijuana near a ranch north of Candelaria. The marijuana consisted of several large cellophane-wrapped bundles contained in four military-style duffel bags. The marijuana was referred to DEA.

Big Bend Intelligence USBP Agents, assisted by CBP OAM, seized 37.48 lbs of abandoned marijuana near a ranch southwest of Marfa. The marijuana was packaged in a cellophane-taped bundle inside a burlap backpack. The marijuana was referred to Alpine DEA.

MARFA SECTOR

USBP Agents seized 295.56 lbs of marijuana and apprehended five IAs on US-90 near a ranch northwest of Marfa. The marijuana was contained in five burlap backpacks. The marijuana and the subjects were referred to Alpine DEA.





DEL RIO SECTOR



On 07 JUL, USBP Agents followed subjects on a ranch near Eagle Pass. The Agents found several duffel bags containing a total of 294.10 lbs of marijuana, which was turned over to DEA. No subjects were found in the vicinity of the drugs.

On 10 JUL, a Dimmit Co SO Deputy was dispatched to a ranch near Catarina regarding a group of subjects. When a USBP Agent arrived, the subjects fled.

During a search of the area, four IAs were apprehended.

DEL RIO SECTOR

On 10 JUL, a Dimmit Co SO Deputy responded to a ranch near Carrizo Springs regarding the discovery of a deceased person.

On 19 JUL, USBP Agents conducted an inspection on a white Ford F-550 pickup on FM 2644 near Eagle Pass, when the driver failed to yield. The Ford drove into brush at a ranch, and the driver bailed out. CBP OAM assisted and located the driver. The Agents apprehended the driver and five IAs. Four of the IAs were concealed in the pickup's tool box. The vehicle was reported stolen from Bexar Co. The driver was arrested as the alien smuggler, and the vehicle was impounded by Dimmit Co SO.

On 25 JUL, USBP Agents encountered a group of subjects hiding in brush at a ranch on US-277 near Carrizo Springs. The Agents identified a USC alien smuggler with five IAs. The USC was arrested as the alien smuggler.

LAREDO SECTOR

On 13 JUL, USBP Laredo
Agents followed a group of
subjects at a ranch near
Laredo. The Agents
discovered five abandoned
bundles in the brush. A total
of 341.44 lbs of marijuana
was seized.



On 16 JUL, USBP Laredo Agents responded to a Drawbridge alert and located an abandoned 2016 Ford F-250 pickup that had crashed through a ranch fence on US-83 near Laredo. Several subjects had absconded. The vehicle was reported stolen from San Antonio.

RIO GRANDE VALLEY





McAllen USBP Agents seized
813.50 lbs of marijuana near Mission.
The Agents responded to a report of a
1998 Dodge Ram pickup leaving a ranch.
The vehicle drove through a fence at a
business. The Agents apprehended two
subjects and discovered the marijuana inside
the vehicle. DPS CID assumed custody of the
subjects and narcotics. The vehicle was seized.

Weslaco USBP Agents seized
307.24 lbs of marijuana. The Agents
observed several subjects with bundles
walking through a cotton field near
Santa Maria. The Agents apprehended
six subjects. DEA assumed custody of
the subjects and marijuana.



RIO GRANDE VALLEY

Falfurrias USBP Agents seized 504.8 lbs of marijuana. The Agents, along with a K-9, inspected a 2016 Chevrolet Silverado pickup hauling a horse trailer. The Agents found bundles of narcotics concealed in a locked compartment in the trailer. The vehicle and trailer were seized. HSI assumed custody of the narcotics.

A Brooks Co SO Deputy responded to a deceased person at a ranch in eastern Brooks Co. The Deputy met with a USBP Agent and was escorted to the location of the body. In seven incidents, Brooks Co SO Deputies, assisted by USBP, responded to the discovery of deceased persons on ranch properties in Brooks county.

A Starr Co SO Deputy responded to notification by a USBP Agent of the discovery of a deceased person on a ranch northeast of La Grulla.

The body was found with a Guatemalan ID card.





