South Texas Ranch Crime Index Total as of August 31, 2017: 49

The Ranch Crime index comprises rancher input of criminal traffic patterns occurring outside of main highways and roadways, and across ranch properties.

MARFA SECTOR

USBP Agents seized 63.50 lbs of abandoned marijuana near a ranch north of Candelaria. The marijuana was referred to Alpine DEA.

USBP Agents seized 195.54 lbs of marijuana and apprehended two IAs, including a juvenile, on a ranch southeast of Valentine. The four bundles of marijuana were wrapped in duct tape. The subjects and marijuana were referred to Alpine DEA.

USBP Agents seized 172.65 lbs of abandoned marijuana on a ranch north of Candelaria. The marijuana was in three sugar sacks that were being used as makeshift backpacks. The narcotics were referred to Alpine DEA.



MARFA SECTOR

USBP Agents, assisted by CBP OAM, seized 283.70 lbs of marijuana and apprehended five IAs on a ranch west of Marfa. The marijuana consisted of five duct-tape-wrapped bundles inside five burlap backpacks. The subjects and the marijuana were referred to Alpine DEA.





USBP Agents, assisted by CBP OAM, seized 186.74 lbs of marijuana and apprehended four IAs on a ranch west of Marfa. The marijuana consisted of four cellophane-wrapped bundles inside four burlap sacks. The marijuana and the subjects were referred to Alpine DEA.

MARFA SECTOR



USBP Agents, assisted by CBP OAM, seized 300.23 lbs of marijuana and apprehended two IAs near a ranch northeast of Candelaria. The marijuana consisted of 27 cellophane-wrapped bundles inside five sugar sacks. The marijuana and the subjects were referred to Alpine DEA.



DEL RIO SECTOR

On 14 AUG, USBP Agents apprehended a total of four IAs. Three IAs were apprehended on a ranch east of Eagle Pass. The group stated that an additional IA had been left behind after losing consciousness. With assistance from DPS AVN, more IAs were observed, and the fourth IA was apprehended.

On 15 AUG, a Dimmit Co SO Deputy conducted a traffic stop on a 2016 Ford F-150 pickup that was reported stolen from Austin, when a pursuit ensued. USBP Agents responded after the truck had crashed through a fence. The Agents located the vehicle near the Nueces River.

On 18 AUG, a Dimmit Co SO
Deputy responded to a
ranch in Carrizo Springs
where a ranch worker had
found skeletal remains.



DEL RIO SECTOR

On 26 AUG, USBP Agents observed a black 2014 Ford F-350 pickup on FM 2688 in Catarina. The vehicle crashed through a ranch fence and was found abandoned. The Ford was reported stolen and had multiple indicators of having been used to smuggle IAs: the front and rear license plates were reported stolen, the rear seats had been removed, and there was a 12-pack of sodas inside. A Dimmit Co SO Deputy impounded the vehicle.

On 28 AUG, USBP Agents were alerted by camera operators of possible IA activity near a ranch in Quemado. The Agents apprehended six IAs. Two IAs were identified as guides, one of whom had seven prior encounters as a juvenile. Two of the IAs were arrested as the alien smugglers.

On 29 AUG, a USBP Agent observed a tan 1998 Ford F-150 pickup on a ranch road in Eagle Pass. Before the Agent could inspect the vehicle, it drove away. A second Agent observed the vehicle and inspected the pickup, and identified the driver as smuggling an IA. The IA was apprehended, and the vehicle was impounded.

LAREDO SECTOR

On 07 AUG, USBP Hebbronville Agents observed a bailout near Hebbronville. The driver and passenger absconded after driving a 2013 KIA sedan through a gate. The Agents seized 290.17 lbs of marijuana from the vehicle.

On 15 AUG, USBP Laredo Agents encountered a 2014 Ford pickup near a ranch headquarters in the Laredo area. The vehicle drove through a fence and into brush, where it was abandoned. The Agents apprehended two subjects near the vehicle. The vehicle was stolen from San Antonio.

On 16 AUG, USBP Cotulla Agents observed a Ford F-250 pickup near Dilley that attempted to evade them. Dilley PD Officers assisted and found the abandoned vehicle in a field. The vehicle was stolen from San Antonio.

LAREDO SECTOR

On 15 AUG, USBP Cotulla Agents on IH-35 observed a 2010 Ford pickup that was suspected of being involved in human smuggling. The Agents followed the vehicle on FM 469 and found a fresh gap in a ranch fence. The vehicle was found abandoned after a search of the area. The vehicle was stolen from Austin.

On 19 AUG, USBP Cotulla Agents along with La Salle Co SO Deputies conducted a traffic stop on a 2017 Ford F-250 pickup, which failed to yield. The vehicle crashed through a ranch fence and the driver bailed out. The vehicle was stolen from San Antonio.

On 21 AUG, a Freer PD Officer conducted a traffic stop on a 2011 Ford F-250 pickup along Hwy 59, when a pursuit ensued. The vehicle drove through a fence, and was not located.

LAREDO SECTOR



On 23 AUG, USBP Laredo Agents responded to activity at a property near Laredo. The Agents seized 582.60 lbs of marijuana.

On 23 AUG, USBP Cotulla Agents observed a pickup traveling south on IH-35 in Frio Co. The Agents followed the vehicle, which exited on CR 1581. The Agents discovered that the vehicle had crashed through a fence and had been abandoned. The vehicle was stolen from San Antonio.

RIO GRANDE VALLEY

Harlingen USBP Agents seized 543.22 lbs of marijuana. The Agents observed eight subjects with bundles run into a sugarcane field west of Los Indios, and later located the bundles abandoned. DEA assumed custody of the narcotics.



Brownsville USBP Agents seized 22.92 lbs of marijuana hidden in a field near US-281. DEA assumed custody of the narcotics.



Rio Grande City USBP Agents seized 182.90 lbs of marijuana. The Agents and an RGV Horse Patrol Unit encountered eight subjects carrying bundles north of La Grulla. The subjects abandoned the bundles when approached, and fled. One subject was apprehended and arrested. HIDTA assumed custody of the narcotics and the subject.

RIO GRANDE VALLEY



Rio Grande City USBP Agents seized 68.30 lbs of cocaine. The Agents observed a 2004 Ford Ranger pickup south of a farm property in the Alto Bonito area. The vehicle was seen along the River before traveling north to US-83. The Agents located the vehicle parked at a business and found the cocaine in bricks wrapped in tape. DEA assumed custody of the subject and narcotics.

A Brooks Co So Deputy and a Justice of the Peace responded to the discovery of a deceased person by a USBP Agent on a property in northwest Brooks Co. There was an El Salvadoran ID with the body.

Weslaco USBP Agents seized 77.30
lbs of marijuana. The Agents
observed subjects walking along the
River, then found bundles in a
nearby sugarcane field. DEA
assumed custody of the narcotics.


A Brooks Co SO Deputy, accompanied by a Justice of the Peace and assisted by a USBP Agent, responded to a ranch in northwest Brooks Co regarding a deceased person. The body was transported to the front gate of the property, where funeral home staff took custody of it.

RIO GRANDE VALLEY

of 13 subjects northeast of La Grulla.

AVN located the subjects in a sugarcane field and guided Agents to them.

A total of 13 IAs were apprehended.



A Brooks Co SO Deputy was dispatched to a ranch in northern Brooks County regarding skeletal remains. The Deputy and ranch foreman traveled to the location and were met by a USBP Agent, who assisted the Deputy with collecting the remains, clothing, and ID for processing.

South Padre Island PD assisted Port Isabel PD in a pursuit of a 1999 Chevrolet Prizm. The vehicle travelled at over 100 mph and went the wrong way on a causeway before crashing into a fence, where the driver bailed out. The driver was subsequently caught with the assistance of USBP and turned over to Port Isabel PD.





