#### South Texas Ranch Crime Index Total as of July 31, 2016: 34

The Ranch Crime index comprises rancher input of criminal traffic patterns occurring outside of main highways and roadways, and across ranch properties.

## MARFA SECTOR

Van Horn USBP Agents seized
1.05 lbs of marijuana and
arrested two IAs on a ranch
several miles west of Valentine.
The marijuana was wrapped in a
bundle. The subjects and
marijuana were referred to
Alpine DEA.

Sierra Blanca USBP Agents arrested 12 IAs by a ranch south of Sierra Blanca. Five subjects were held in El Paso pending prosecution.



#### **DEL RIO SECTOR**

On 16 JUL, a USBP Agent observed four subjects crossing a roadway south of Eagle Pass. USBP Agents located four IAs hiding behind pallets at an orchard. One of the IAs was identified as the principal alien smuggler.

On 21 JUL, a TPWD Game Warden received information from Dimmit Co SO Deputies regarding IA subjects who had called 911. They stated that they had been lost in the brush for 15 days, and needed assistance. The Game Warden located the four IAs off a ranch road near Big Wells. Dimmit Co Deputies believed the IAs were part of a bailout that had occurred earlier that morning.

#### LAREDO SECTOR

On 21 JUL, Webb Co SO Deputies responded to the report of a deceased person on a ranch near Bruni. USBP Agents advised that the female had been part of a group that had been apprehended nearby two days prior to the discovery. The decomposed body was turned over to Webb County Medical Examiner's Office.







DPS AVN assisted USBP with locating a group of seven IAs north of Sullivan City, and USBP took them into custody. AVN then assisted Pharr PD with a pursuit. The driver drove into a corn field, where he bailed out and attempted to hide among the corn stalks. AVN quickly spotted the driver, and he was arrested.

DPS AVN observed a
Chevrolet pickup hidden in
an orchard in Mission. A
THP Trooper arrived and
determined that it was
stolen from Hidalgo County.





AVN observed a Dodge pickup from which IAs had bailed out. A pursuit ensued, and the vehicle traveled through multiple properties before stopping at a residence near Edinburg. USBP ground units arrested the driver.





Weslaco USBP Agents seized 640.25 lbs of marijuana. The Agents observed subjects carrying bundles into a sugarcane field, set up a perimeter of the area, and conducted a thorough search. The Agents found the bundles and arrested 13 smugglers. The subjects and the narcotics were turned over to DEA.







A Brooks Co SO Deputy responded to the Hollywood Camp Gate regarding a deceased person who had been found by a ranch worker. A cell phone and an El Salvador ID were found nearby.

A Brooks Co SO Deputy was dispatched to a ranch in central Brooks County regarding a deceased person found by a USBP Agent.








A Brooks Co SO Deputy was dispatched to a ranch in Encino regarding a deceased person. A cell phone was found with the body. USBP Agents brought the JP to the location.

A Brooks Co SO
Deputy was dispatched to a ranch in Encino regarding skeletal remains. The remains were transported to the Brooks Co SO.







A Brooks Co SO Deputy was dispatched to a ranch near Falfurrias regarding a deceased person.



A Kenedy Co SO Deputy responded to US Hwy-77 near the USBP checkpoint regarding a deceased person.

The body was found with a Mexican ID.



A Brooks Co SO Investigator responded to a ranch in southwest Brooks County regarding a deceased person who was found on the property. Two spent shotgun shells were found near the body, which had a Guatemalan ID.



Brooks Co SO was dispatched to a ranch near Falfurrias regarding a deceased person. The remains were taken to the Brooks Co SO and the Webb County Medical Examiner's Office.



Brooks Co SO Deputies responded to a ranch regarding skeletal remains. Clothing and documents found at the location identified the deceased as a Mexican male. The investigation is ongoing, and the autopsy is pending.



Brooks Co SO Deputy responded to a ranch regarding a deceased person. It was discovered under a tree with clothing that contained a Nicaraguan ID. The body was turned over to the local funeral home.


## COASTAL BEND SECTOR

On 08 JUL, a Bee Co SO Deputy conducted a traffic stop on a 1999 Ford Expedition, when a pursuit ensued. The vehicle crashed into a fence and an unknown number of subjects bailed out and absconded.

On 12 JUL, a Goliad Co SO Deputy conducted a traffic stop on a 2004 Ford F-150 pickup when a pursuit ensued. The vehicle crashed through a fence and lost control. After the vehicle stopped, seven subjects bailed out and absconded. The deputy seized a user amount of cocaine.

## DRAWBRIDGE ALERTS

On 13 JUL, USBP Agents were dispatched to a ranch near US-277 near Quemado regarding a Drawbridge alert. With assistance from CBP/Air & Marine, the Agents detained four IAs and seized 272.6 lbs of marijuana. A DEA Agent and a DPS Agent arrested the IAs.





