The Ranch Crime index comprises rancher input of criminal traffic patterns occurring outside of main highways and roadways, and across ranch properties.

BIG BEND SECTOR

On 09 AUG, a Brewster Co SO Deputy was dispatched to a ranch near Big Bend National Park regarding suspected IAs in the area. The Deputy detained an IA who was referred to USBP at the Alpine Checkpoint. The IA was processed.

On 10 AUG, Brewster Co SO Deputies and USBP Agents located a deceased person on a ranch northeast of Study Butte. The body is pending an autopsy.

On 21 AUG, USBP Agents seized 0.003 lbs of cocaine that had been found abandoned by a rancher who had been picking up trash around his gate near the Marfa Checkpoint. The cocaine was referred to Alpine DEA.

On 28 AUG, USBP Agents seized a 1997 Ford F-150 pickup and apprehended a human smuggler and eight IAs following a failure to yield on FM 2810, south of Marfa. The vehicle was driven through three ranch fences before coming to a stop. The case was referred to Alpine HSI.

BIG BEND SECTOR

On 30 AUG, USBP Agents seized 228.09 lbs of marijuana and apprehended an IA on a ranch east of Van Horn. The marijuana was found in four large burlap backpacks. The case was referred to Alpine DEA.









On 30 AUG, USBP Agents, assisted by DPS AVN, seized 343.88 lbs of marijuana and apprehended six IAs on a ranch west of Valentine. The marijuana was found in six large burlap backpacks. The case was referred to Alpine DEA.

DEL RIO SECTOR

On 03 AUG, USBP Agents encountered nine IAs on a ranch near FM 2644 east of Eagle Pass. Several of the IAs were suffering from severe heat exposure and dehydration. EMS personnel were dispatched to assist. One subject became unresponsive and could not be revived. The Agents treated the remaining IAs for heat exhaustion, sent two of them to a hospital for emergency treatment. The IAs were processed, and the deceased subject was referred to Maverick Co SO.

On 04 AUG, a Uvalde Co SO Deputy conducted a traffic stop on a John Deere Gator on US-83 that had been stolen from a ranch in Zavala Co. A USBP Agent assisted, and identified the subject as an IA. The vehicle was impounded.

On 07 AUG, a Kinney Co SO Deputy found a group of subjects on a ranch near US-277 west of Spofford. USBP Agents apprehended 10 IAs, including juvenile subjects who were suffering from severe heat exposure and dehydration. The Deputy assisted the Agents and EMS, and after the juvenile subjects were medically cleared, the Agents processed the IAs.

DEL RIO SECTOR

On 25 AUG, a USBP Agent observed a white 2016 Chrysler 300 and a silver 2013 Chevrolet Silverado pickup traveling in tandem on RR 674 north of Brackettville. The Agent conducted an inspection on the Chrysler 300, and detained two occupants. The Silverado stopped by a ranch, and several occupants bailed out. The Agent apprehended three IAs and the USC driver, who was identified as the human smuggler. The two occupants of the Chrysler 300 were identified as scouts and human smugglers. The subjects were processed, and a Kinney Co SO Deputy impounded both vehicles.

On 25 AUG, USBP Agents observed three subjects emerge from the River and walk into the brush on a ranch west of Spofford. The subjects were approached and identified as three IAs. One of the subjects was also identified as a registered sex offender and arrested for Re-entry into the US.

DEL RIO SECTOR

On 29 AUG, a USBP Agent observed a gray 2007 Nissan Altima driving in tandem behind a gray 2014 Ford Focus on RR 647, north of Brackettville. The Agent conducted an inspection on the Altima, but the Focus failed to yield. The Altima stopped, made a U-turn, and headed south on RR 674. The Agent followed the Focus, but it sped away. The Agent located the Altima abandoned on RR 674, north of Brackettville. No subjects were found in the area. Before the Agent located the Altima, an Edwards Co SO Deputy was dispatched to assist in the search for the Altima. Later, local ranchers gave a ride to a pedestrian who was walking on RR 674 and referred him to the Agent. The pedestrian admitted to having been the driver of the Altima, and also admitted he had IAs in the vehicle with him. The human smuggler also identified the two subjects in the Focus as scouts for his human-smuggling attempt. The driver of the Altima was arrested for human smuggling. Later that day, a USBP Agent detained nine IAs who were walking on a ranch near US-277, south of Del Rio. One of the IAs was identified as the guide/human smuggler. The guide was arrested for human smuggling, and the remaining IAs were processed. The nine IAs were believed to have been passengers from the Altima and Focus.

LAREDO SECTOR

On 01 AUG, Laredo North USBP Agents received information from HSI regarding a narcotics-smuggling event on a ranch near Laredo. The Agents found and seized 221.70 lbs of marijuana, and referred the narcotics to HSI.

On 07 AUG, Webb Co SO Deputies responded to reports of USBP Agents recovering human remains that had been found on a ranch near Laredo.

On 14 AUG, Webb Co SO Deputies assisted USBP Agents with the recovery of a deceased person discovered on a ranch along FM 1472 near Laredo. The deceased person was wearing blue jeans, a long-sleeve shirt, a cap, and a backpack.

LAREDO SECTOR

On 21 AUG, an Encinal PD Officer was dispatched to the SH-44 area to assist USBP Agents with the pursuit of a red 1999 Dodge Ram 1500 pickup. When the vehicle stopped on a ranch, the Agents apprehended the driver/USC human smuggler and four IAs. The vehicle was seized, and the driver was arrested. The Agents assumed custody of the IAs.



On 26 AUG, a THP Trooper conducted a traffic stop on a white 2016 Ford F-250 pickup on IH-35 near Laredo, when a pursuit ensued. The vehicle was driven through a ranch fence at MM18 near Laredo and continued across the property. USBP Agents assisted the Trooper in locating the vehicle, and it was identified as stolen from San Antonio.

On 27 AUG, Laredo North USBP Agents encountered a stolen blue 2017 Ford F-250 pickup on SH-44 by a ranch near Laredo. The vehicle, which was reported stolen from San Antonio, was referred to THP Troopers.

LAREDO SECTOR

On 25 AUG, a Webb Co SO Deputy was in pursuit of a black 2003 GMC Envoy on US-83 when the driver of a gray 2003 Toyota Sequoia attempted to run the Deputy off the road as the Deputy was in pursuit of the GMC. The Toyota then began to tailgate the Deputy as they continued on US-83 southbound. The GMC pulled up to a ranch gate and several subjects bailed out from the vehicle. The Deputy detained three subjects who were in the back seat of the vehicle and admitted to being IAs. The Deputy conducted a traffic stop on the Toyota on US-83 and detained the driver. The driver was charged for Aggravated Assault on a public servant. The three IAs were referred to USBP, and the driver of the Toyota was transported to Webb Co Jail.



On 30 AUG, Laredo North USBP Agents responded to a Drawbridge camera activation near a ranch north of Laredo involving a purple 2006 Chevrolet HHR. The Agents conducted a vehicle stop on the vehicle on IH-35 and seized 331.90 lbs of marijuana. The driver was arrested, and the vehicle was seized. The case was referred to DEA.



RIO GRANDE VALLEY

On 13 AUG, a Kenedy Co SO Deputy responded regarding a deceased person found on a ranch near Sarita. USBP Agents escorted the Deputy to the location of the body, and an inventory was taken of the personal possessions.

On 14 AUG, TPWD Game Wardens detained 16 IAs in Rio Grande City. The subjects were observed in a driveway leading to a farm field. The IAs were referred to USBP.

On 16 AUG, a Brooks Co SO

Deputy responded to a ranch
west of Falfurrias regarding
human remains.

On 17 AUG, a Kenedy Co SO
Deputy responded regarding a
deceased person found on a
ranch in Armstrong.

USBP Agents escorted the Deputy
to the location of the body.

On 21 AUG, a Brooks Co SO
Deputy responded to a ranch
in central Brooks County
regarding a deceased subject.
The body was transported to
the Webb Co Medical
Examiner's Office.

COASTAL BEND SECTOR

On 06 AUG, Jim Wells Co SO Deputies conducted a traffic stop on a silver 2010 Chevrolet Silverado pickup on US-281 near Ben Bolt, when a pursuit ensued. The vehicle was driven through the brush and onto a ranch.

The vehicle was located abandoned and was seized.





